Civil

Approximately 1/3 of civil cases were disposed by default judgment, while almost 1/5 were settled.

About 1/3 of Administrative Review and Small Claims cases went to bench trial.

Over 2/5 of Contract and Real Estate cases were disposed by default judgment.

More than 3/4 of Tort cases and 1/2 of Extraordinary Remedy cases were dismissed.

Domestic Relations

One-third of domestic relations cases were settled, while about 1/6 went to bench trial.

Over 1/3 of Paternity cases and 1/4 of Modification cases went to bench trial.

More than 3/5 of Marriage Dissolution and 2/5 of Modification and Paternity cases were settled.

Approximately 2/3 of Adult Abuse and 4/5 Child Protection Order cases were dismissed.

Criminal

Nearly 3/4 of criminal cases were disposed by a guilty plea, while almost 1/5 were dismissed.

Over 4/5 Circuit Felony trials resulted in a finding of guilt.

Almost 9/10 of Circuit Felony and 4/5 of Misdemeanor and Traffic cases resulted in a guilty plea.

Approximately 1/6 of Associate Felony and 1/5 of Misdemeanor and Traffic cases were dismissed.
